CERTIFIES

That the Third Party Liability policy Number 96.119.524 contracted by this Company with the Royal Spanish Federation of Motoring covers:

A) Coverage for damages to third parties required by Article 14, entitled "Obligations of the Unitholders" of the Annex II to Royal Decree 1428/2003 of December 21 (BOE n2 306, of December 23) in which states that "all participants of the test must have liability insurance Coverage that covers possible damages to third parties up to the same limits as for personal and material damages as it is established in the Royal Decree 1507/2008, of September 12, for the civil liability insurance of motorvehicles of obligatory subscription:

- Limit material damages: 15,000,000.- Euros.
- Limit body injuries: 70,000,000.- Euros.

Additionally, it is stated that:

- For this Coverage, all participating drivers and participants in the testing will be considered insured, whether they compete or not, throughout their participation, during the trainings and during testing (timed and link sections).
- They will also be considered third parties unless they are the driver of the vehicle involved or participant that causes the damage, or the co-drivers of the vehicles competing in the event while they are inside the vehicle causing the damage.
- The Coverages of this policy are adapted to the modifications introduced by Law 21/2007, of 11 July, which modifies the revised text of the Law on civil liability and insurance in the circulation of motor vehicles, approved by R.D.L.8 / 2004, of October 29 and by the Regulation of applicable development.

B) The following Coverages with a limit of € 5,000,000 per claim and in the annual aggregate with respect to their general activity (exploitation) and promotion, organization and development of motorsport at State level, and for those that will be considered third parties other than the Insured (including relatives):

- General Liability
- Accidental Pollution Liability
- Damage to rented buildings.
- Products Liability
- Professional Liability (Policyholder Technicians)
- Employers Liability
- Cross Liability:
 - Bodily injury, with regard to the organization of events, goods / vehicles of employees and / or third parties in custody.
 - Bodily injury to contractors / subcontractors.
 - Damage to pre-existing goods in circuits

The policy has been contracted since January 1st, 2022 and in force until its annual expiration on December 31st, 2022.
